
One vessel's vital role in local history...

# The Sloop-of-War Decatur in the Pacific Squadron

Join historian Lorraine McConaghy for an illustrated presentation of her research on the warship DECATUR, and its 1854-1859 cruise in the Pacific Squadron.

Supported by a Hooper Fellowship, McConaghy spent last summer working in the Old Navy records at the National Archives in Washington, DC, and researched logbooks, correspondence, court martial records, and medical journals for the ship. Other archival research has yielded a rich story, beginning in the 1830s and ending during the Civil War.

The DECATUR was on station in Puget Sound for nine months, 1885-

1856, during the Treaty War, and was in Elliott Bay much of that time, either anchored or on shore under repair. The ship defended Seattle against Indian siege through the winter and early spring of 1855-1856, and on the day of the Battle of Seattle, January 26, 1856. Research into the personal papers of some of the ship's officers has yielded a rich treasure trove of material, including the first known drawings of Seattle, sketched by Navy surgeon John Y. Taylor.

Lorraine McConaghy holds a Ph.D. in U.S. urban history from the University of Washington, and she has published and taught Pacific Northwest history since 1993. She has taught history at Pacific Lutheran University and the University of Washington, and began working as the staff historian at the Museum of History and Industry in Seattle in 1997.

Aside from being an award-winning author - having written or co-written several articles and books on Pacific Northwest history - Dr. McConaghy is a much sought after speaker - mark your calendars and plan to join your fellow Pioneers for what will surely be a fascinating afternoon.

### President's comments

It doesn't seem possible that we are finishing the first quarter of 2006! I hope this new year finds you healthy and as busy as you like with people and activities you enjoy. We had a fine program in October - it began with our traditional short update on business, followed by a family history by Jeff Christensen, whose ancestors came from Ireland (via New Brunswick, Canada) to settle in the San Juan Islands, Washington Territory. Doug Jackson, president of Friends of Olmsted Parks, was the featured speaker of the day and gave a wonderful presentation on the history of Olmsted Brothers parks in Seattle. Music, refreshments and visiting completed the afternoon.

Also during the Fall Meeting, Historian Gary Zimmerman cited the passing of several longtime members, as well as announced the names of new members who had joined since the Annual Meeting last June. As of now, we are missing two very active former members: Board Member John Gayton, who passed away November 7, 2005, as well as Past President Shirley Wright.

John Gayton served on the Pioneer Board for several terms until ill health required his resignation last year. More recently, we were saddened to hear of the unexpected February 25 passing of Shirley Wright. Shirley was a current Board Member at the time of her death, as well as a Past President of the Association. She was still very active with both that group, as well as the Daughters of the Pioneers. Remembrances may be made to the Pioneer Association. We'll do more to recognize Shirley's life and accomplishments in the next issue of Pioneer Presences.

On November 12, we held a potluck luncheon to welcome new members. About thirty five total members attended, sharing their own stories

of pioneer ancestors and traditions.

Other happenings at the Hall include changes that will make materials there more accessible to members and the public. We are about to start putting book plates into books from the Pioneer Library Collection to identify them from those belonging to the Daughters collection on the first floor. The design was created by Shirley Wright's daughter, Kathleen Schumer.

## Pioneer John Gayton (1931-2005)


John Cyrus Gayton (1931-2005) an active member of the Pioneer Association and a pioneering community leader in his own right, died this past November after a struggle with cancer and complications from diabetes.

John Gayton was the grandson of early Seattle pioneer John T. Gayton (1866-1954), who came to Seattle in 1899 from Mississippi as a coachman and established himself as the head of one of Seattle's leading African-

American families. The younger John Gayton continued that legacy through his own pioneering accomplishments in business and through his dedication to community service.

John was born in 1931 to John Jacob and Virginia Clark Gayton. He attended Seattle University, where he received an appointment to attend West Point Military Academy (although he ultimately did not attend West Point). During the Korean War he enlisted in the Air Force, where he was awarded several medals, including the National Defense Service Medal.

John went back to school after the war and received a Bachelor's degree in Business Administration from the

University of Washington: the only African-American in his class. He later went back to the UW to receive a Master's degree in the same program.

John was recruited as the first African American Company Representative for the Olympia Brewing Company, where he led the company's first targeted outreach into the African-American market. John spent time in California before returning to the Pacific Northwest to work as one of the first African-Americans in management at United Air Lines.

John opened his own consulting firm in the early 1970's, working with major local and national corporations, much of his work heavily emphasizing Affirmative Action.

Over the years, John gave his time and energies to numerous local agencies and organizations, including chairing the Central Area Citizens Committee and the Central Area Motivation Project (CAMP). He served for over 30 years on the board of the East Madison YMCA, and was repeatedly recognized for his work with that organization. He was an active member of the University of Washington Alumni Association, as well as a life member of the NAACP, Urban League, and the Alpha Phi Alpha faternity. He was also an active member of the African Methodist Episcopal Church.

Of course, John was also a longtime and beloved member of the Pioneers of the State of Washington, and served on its board in several capacities over the years. His graceful presence and sage counsel will be missed.

The mission of the Museum of History & Industry is to collect, preserve, interpret, and share the history of the people of Seattle, King County, and the Pacific Northwest.

**Hours:** daily 10:00 - 5:00 Admission: \$7 adults, \$5 seniors and ages 6-12, \$1.00 ages 2-5, free for members and children under 2.

**Permanent displays:** Denny Party Landing 1851, Seattle 1880s, Great Seattle Fire, Salmon Stakes, Boeing's first commercial plane, Bobo the Gorilla.

Collections, archives, and research material: 80,000 three-dimensional artifacts, 1,200,000 historic images, and 200,000 manuscripts and other archival texts. The Sophie Frye Bass Research Library is open by appointment. MOHAI has been collecting artifacts, images, and written material since 1911.

**Programs:** Mohai has special events and programs year-round. Activities range from Nearby History, a program that teaches and empowers amateur historians, to walking tours of historic neighborhoods and sites, plus lots of other activities for children, parents, and grandparents.


### Kirk Gerrard

# Pioneer Milestones: Recent deaths of pioneer members

Among the several deaths reported to the Association since the Fall issue of Pioneer Presences:

**Mildred C Gookstetter**, of Carnation, passed away on June 27, 2005, at the age of 91. A Life Member, she joined the Association in 1984. Her grandfather, George W Frost, purchased property in Davenport, Lincoln County, in the summer of 1889. He moved his family up from California to join him, with Mildred's mother arriving in Davenport at the age of six weeks. Her grandson, Duane S Gookstetter became a member in 1993.

**C. Keith Birkenfeld** of Bainbridge Island and Palm Springs, California, died on September 7, 2005, at the age of 66. His great-grandfather, Benjamin H Keith, came to Seattle in 1888. Keith's grandfather, H.H. Keith, created the bust of Chief Seattle that now stands in Pioneer Square in Seattle. Keith Birkenfeld had been a member since 1991; his grandfather had joined the Association in 1965.

**John Cyrus Gayton** of Seattle died on November 7, 2005, at the age of 74. He first joined the Association in 1981. He recently served two terms on the Board of Trustees of the Association. John's grandfather, John Thomas Gayton, a native of Mississippi, settled in Seattle in April, 1889.

**Arthur William Hademan, Jr**, died in Mount Vernon, Washington, on February 2, 2006. An associate member since 1959, Arthur's was married for 56 years to his late wife, Doreen (Kimsey) Hademan, who was descended from her pioneer grandparents, William Bartlett Kimsey and Catherine Elizabeth Kimsey, who settled in Sterling in 1888.

**Shirley Louise Wright**, of Bothell, died at home on February 25, 2006. She was the immediate past president of the Pioneer Association. She died the day before her 83rd birthday. A member since 1984, Shirley was descended from pioneer Marietta Crow Settle. A more complete story will follow in the next issue.

### Pioneer News and Notes

It's been a busy year already for members of the Pioneer Association. Vice President **Junius Rochester** was a featured presenter at Pacific Northwest Historians Guild Annual Conference on March 4, giving a presentation on "Sam Hill: Legend of the Columbia Gorge". Junius has also been busy acting as ship's historian aboard the *Queen of the West*, a paddlewheel riverboat which cruises the Columbia River between Washington and Oregon. In the words of one travel writer, Junius' "daily lectures, insightful musings and morning vignettes (make) the history of the region simply come alive."

Pioneer Association Historian **Gary Zimmerman** has been a busy presenter himself. Aside from all the work he does for the Fiske Genealogical Foundation, Gary will spend much of March and April making presentations at several historical and genealogical gatherings. Among his appearances will be a March 18 presentation on German research at the South King County Genealogical Society's "Gene-a-Rama '06" event. Then, on April 8, Gary will be speaking at the Washington State Genealogical Society's State Conference and Annual Meeting. His topic: "British & American Quaker Roots".

Last month, Pioneer Association member Louise Jones-Brown joined the Friends of Georgetown "Celebrate the History of Georgetown" by giving a presentation on "Jacob Maples - Duwamish Valley's First Pioneer". The presentation - similar to one she gave last year to our own group - included some of Louise's research on her family's contributions to the settlement of King County, as well as original family oil paintings featuring local historical figures, sites and events.



## Planning begins for centennial anniversary of Seattle's A-Y-P

In 1909, the Alaska-Yukon-Pacific Exposition (A-Y-P) commemorated the first shipment of Klondike gold through Seattle in 1897. The A-Y-P, held on what are now the grounds of the University of Washington, consisted of exhibits, rides and food. It also attracted more than 3.5 million visitors from around the world, giving Seattle much-needed prominence and attention as a leader in Pacific trade.

As the 100 year anniversary of this important event approaches, Pioneer Association Vice President Junius Rochester reports that he is a member of a committee planning a salute to the Alaska-Yukon-Pacific Exposition (1909), around the time of its anniversary.

Junius' own father, former Seattle City Councilman Al Rochester, was

actually the spark behind the first (50th) anniversary celebration of the A-Y-P – a spark that turned into one of the great lasting legacies of Seattle: the 1962 World's Fair. Due to the grand scale of the event and the immense planning it required, the 1962 World's Fair actually occurred a few years later than what would have been the 50th anniversary of the A-Y-P – which was rather appropriate, since the A-Y-P itself had been delayed (for the very same reasons) for two years - the 10th anniversary of the gold rush it celebrated would have been in 1907.

The committee planning the centennial anniversary is chaired by Leonard Garfield, Director of the Museum of History and Industry. Junius believes that the Pioneer Association has souvenirs from the A-Y-P and might benefit from involvement with this planned activity. He will keep the Association informed.
