The man who launched the Lewis & Clark Expedition

Thomas Jefferson visits Puget Sound (in his imagination)

On Saturday, June 24, local author and historian Junius Rochester will give a presentation about Thomas Jefferson, as part of the Annual Meeting & Salmon Bake of The Pioneer Association of the State of Washington.

Thomas Jefferson saw his 18th century world as rural, idyllic, and stretching beyond the Mississippi River. He recruited several adventurers to explore the Columbia River, even before the Lewis & Clark trek. Jefferson's library – perhaps the largest in America in the late 1790s – contained many volumes about the "Oregon Country." He was an avid collector of fur trader anecdotes,

Indian myths, and botanical and zoological samples about the West. Jefferson's knowledge about the West, including the North Pacific, Puget Sound, and the great rivers of Oregon, may have been more extensive than any other American of his time.

Jefferson's version of the Enlightenment replicated the European search for answers to everything. In his old age our third U.S. president never lost sight of his interests. He corresponded with hundreds of people in several languages and undertook founding the University of Virginia. Although the Louisiana Purchase changed the physical character of America, the cultivation of his "Garden" (Jefferson's unknown Western lands) and the charting of North American rivers and mountain ranges continued with gusto.

Let's take a look at what Jefferson knew, or thought he knew, about our Puget Sound country.

Junius is the author of five books on Northwest history, is a frequent contributor to magazines and for the last seven years has been a weekly commentator on KUOW FM radio. A member of the Pioneer Association Board of Directors, he is a past-president of the Pacific Northwest Historians Guild.

We lose another beloved member...

Shirley Louise Wright (1923-2006)

Shirley, a long-time member of the Daughters of The Pioneers, as well as the Pioneer Association of the State of Washington, passed away on February 25, 2006, in Bothell.

Shirley was born on February 26, 1923, in Seattle. Her pioneer ancestors included her great-great-grandmother, Marietta Settle, who came West with her husband, George Crow, and family in the mid-1800's. Shirley's great-grandmother, Martha Crow Robinson, was born along the Oregon Trail, in Missouri, one of five children born to her mother, Marietta. The family settled on land that is now Milwaukee, Oregon and eventually moved to Portland.

While in Portland, George Crow became ill and a doctor by the name of Settle attended to him. When George Crow died, Marietta Crow married Doctor Settle and, in 1860, the family moved from Portland to Seattle.

Dr. Settle became only the second doctor in Seattle - Doctor Maynard having already settled in the area. Settle often assisted "Doc" Maynard in his practice and eventually became the city's first coroner. He and his step-son, James Crow, were active in building the first Territorial University Building in Seattle, and Dr. Settle was one of a small party of men that explored and helped to open the Newcastle Mines, east of Lake Washington. The oldest boy in the Crow family, James Jermaine Crow, filed a claim on a homestead of 160 acres southwest of Kent, bringing hops to the valley.

Shirley was very proud of her family and their early roots in Washington. She was a loyal member of Seattle Chapter of The Daughters of the Pioneers and the Pioneer Association of Washington - serving as President of both groups. She worked tirelessly for both groups without fanfare. One year, Shirley built a beautiful doll house (complete with lights!), including all the furniture. The dollhouse has an honored place on the second floor of Pioneer Hall. She also made and dressed many pioneer dolls that were won by drawings at historical occasions.

For many years, Shirley published the yearbooks for The Daughters of the Pioneers. She assisted in cataloging and storing 800 garments belonging to The Daughters, as well as 200 hats. As State Library Chairman, she helped to place the State Daughter's special book collection at its current home, in Pioneer Hall. Proving she was a go-getter, Shirley took over the helm of the Pioneer Association when she was already 80 years old.

We will miss seeing her smiling face come bustling into Pioneer Hall, full of enthusiasm for the next assignment. We are thankful for her many (many) contributions and grateful for the opportunity to know her.

We spotlight area museums...

Lewis County Historical Society

Each issue, we plan to highlight one of the many fine historical museums in our state.

Mission: The Lewis County Historical Society is a private non-profit organization dedicated to preserving the history and heritage of Lewis County through the operation of the Lewis County Historical Museum.

Permanent displays: The Museum depicts the early settlements and pioneer life in Lewis County, one of the first areas settled in the region and the oldest county in Washington State.

Permanent exhibits include a Native American display of Cowlitz and Chehalis tribal material, a blacksmith shop, and a second-hand store dating from the early 1900s. A children's handson exhibit area features a mercantile store, old time kitchen, and an activity table.

Other displays reflect the predominance of the logging, and a model railroad is currently being constructed.

Members of the Association in attendance at the April 1 general meeting of the membership were treated to an early "sneak peek" at new information about the sloop-of-war *Decatur* and the many, varied roles it played during its colored history - including its involvement in the so-called "Battle of Seattle". The presentation featured recent revelations uncovered by local researcher and historian Lorraine McConaghy, of the Museum of History and Industry. McConaughy recently submitted a manuscript of a book on the subject, and the presentation she

Pioneer Milestones: Recent deaths of pioneer members

Since the April issue of Pioneer Presences, the Association has learned of the following deaths which occurred since our Annual Meeting in June, 2005:

Life member **Doris May Carrington**, who first joined the Association in 1967, died in Seattle on September 20th, 2005. Her pioneer ancestors, Charles and Ida Carrington, came to Columbia City in 1889.

Elaine Eldridge died in Seattle on December 23, 2005 at the age of 96 after 40 years of membership in the Association. She was descended from the pioneer Brygger family. Her first husband, Joshua Green, Jr, who had joined the Association in 1947, passed away in 1985. Elaine remarried to Eugene Eldridge who died in 2004 at the age of 100.

On December 1, 2005, **Alice M Holcomb** passed away at the age of 101. A Life member of the Association, she had been a member since 1965. She was descended from her pioneer parents, John A Whalley and Clara (Dickey) Whalley. Alice attended the annual salmon luncheon in June, 2004, at the age of 100.

Silas G Jue died in Sunnyvale, California on October 24, 2005. A member of the Association since 1980, Silas was descended from Seattle pioneer Goon Dip.

Hilton Hayden Lysons, a member since 2002 died on 29 March 2006 in Mercer Island at the age of 92. He was descended from Washington pioneers Jesse Fowler and Crumline LaDu, who came to the present site of Longview in 1850. He also was a lineal descendant of Roger Williams, the founder of Rhode Island.

Pioneer News and Notes

Historian **Gary Zimmerman** was contacted a while back by a descendant of the **Bagley/Mercer/Jenner** families, who let it be known that her own family was interested in making a split donation of some family memorabilia to the University of Washington, as well as our own Pioneer Association. Among the items are family papers, letters, photographs and other items of local historical significance. Gary will be working with the family member and the University of Washington to arrange details for the donation.

Many Pioneers are stepping forward to make contributions to the memorial fund set up in the name of former President **Shirley Wright**, who died this past February. Similar contributions were made to a separate fund after the death of another former officer, **John Gayton**. Memorials like these not only honor the accomplishments of some of our most beloved members, but they benefit the organizations and programs that were near and dear to those members' hearts.

Chris Raaum, who recently stepped down from the Pioneer Board, has graciously agreed to begin videotaping various Association presentations in an effort to further document pioneer stories. We've had a lot of wonderful speakers over the years and videotape allows us to record their appearances for posterity and for playback at future events (such as our bi-monthly Open House sessions).

The Pioneer Association has received word from local attorneys that it is one of the benefactors listed in the Will of former member **Keith Birkenfeld**, who died this past year. The money came with a stipulation: that it be applied toward the Association's Building Fund, which was established for the preservation and overall maintance of Pioneer Hall. How the money will be used is still being discussed, but the Association certainly appreciates this wonderful endowment.

Meeting Mintues of the Board: May 13, 2006

Meeting called to order at 9:35 a.m. by President, Carol. Minutes of April 1 meeting read by Peggy. Minutes approved as read.

The nominations committee with spokesperson, Helen Smith, gave the nominations as follows: Trustees to June 2008 - Kirk Gerrard, Peggy Parietti, Trustees to June 2009 - Loren Rankin, Louise Jones-Brown, Sylvia Gayton Wesley, Betsy Losh; Video Chairman, Chris Raaum.

Motion was made by David that we accept the slate and thank the committee for their diligent work. Seconded by Catherine. Motion Passed.

A raise for Marge Lutton was discussed. She is now paid \$8 an hour. It was recommended we raise to \$10 an hour. An amendment was suggested by David - If we charge renters a cleanup fee, then give Marge \$20. Seconded and passed. Motion made to increase the hourly wage to \$10. Seconded and passed.

Catherine and Carol will host the Open House this Sunday (Mother's Day). There are still Sundays open with no volunteers. Larry Puffert has offered to chair the Open House committee for 2006-2007.

Kathleen Schumer, Shirley Wright's daughter, has designed bookplates for our library books. Gary showed us the design and suggestions for wording on the plates. We all agreed that books donated to the library should have a bookplate with the honoree name (if given), the donor and date of gift.

Catherine showed us some of her latest work, done with the help of a book Carl Nordstrom loaned her. It contained stories of pioneers, many whose photos are on the Hall walls. Junius also helped by doing some history research. From these aids she typed large nameplates with information on her shadow boxes. They are very professional! Catherine reported there are 276 photos on the wall and she now has 101 stories of these people. She has a book ready to publish containing these stories. The radio group, with whom Marge Lutton put her in touch, are interested in taping these stories to be used in the museum by people touring the Hall.

When asked about using Pioneer members' applications for information, Gary said the early members did not have a story - just dates and ancestors.

Carol showed us the plaque made in memory of Shirley Wright, which will be placed on her doll house. Alongside will be a photo of the actual historical house in Port Angeles and a photo of Shirley and her doll house.

Peggy reported that the caterer for the annual meeting picnic will once again be Terentino's. The menu will be baked salmon, fresh fruit, spinach salad, roasted red potatoes, rolls and butter, apple crisp, coffee and tea. Lunch will be served at 12:30. Total cost, including tax and tip, is \$1,046.05. Deposit of \$500 is due to them by May 20. Gary figured \$22 a plate will need to be charged to the members.

David made a motion for adjournment. Junius seconded it. Passed. Time was 10:50 a.m.


